# LETTER FROM THE PRESIDENT AND CEO

Serving the greater community through the arts continues to be a priority for The Arts Council, and this year the engagement efforts of our Board of Trustees, staff, artists, and arts organizations allowed us to create new programs, new targeted initiatives, and serve new audiences throughout Forsyth County.

By focusing our efforts to learn more about our changing community, we know that Forsyth County continues to grow and evolve. While our community changes, we are focusing our efforts on the wants and needs of the community by investing in our youth and education, encouraging economic growth, building an inviting and enriching environment, and focusing on the health and well-being of the members of our community. The arts play an important role in each of these, and represent an investment in the quality of life for the individuals who live here and the businesses that grow here.

Strategic efforts have been made to build on our past grant awards by encouraging collaboration, inclusion, diversity, and purpose. We involved art teachers and administration in our Arts In Education grants process to ensure that the selected programs align with the NC Common Core and are equitably distributed in the school system. We also implemented a new initiative that will focus on arts teacher professional development, allowing arts teachers the opportunity to attend a variety of field-specific conferences and seek additional arts education training.

We want to instill the love of arts in children at an early age, and continue their cultural interests after the school bell rings. By focusing on early-learning and after-school enrichment, we hope to prepare children for a lifetime of learning and introduce entire families to new art experiences that they can share.

Emotional and physical health is paramount in any community. More research shows that the arts can have a positive impact on health, healing, and the well-being of individuals and groups. As part of our holistic efforts of integrating arts and culture into the community, The Arts Council will be supporting creative arts and cultural experiences for patients and community members that create measurable improvements in the health and wellness of our community in the year to come.

Though Arts Council-sponsored programs like the Summer Park Series, ArtPop, and The Burke Street Food Truck Festival, we are able to offer art in unexpected places through free concerts in our County parks, beautiful art on the roadways, and local artisans and musicians the opportunity to reach diverse audiences who seek new ways and venues to experience art and culture.

We launched the Creative Ventures Fund, which was established to aid in the development of local solutions to how artists and creative ventures sustain themselves. The fund can be used to create new ventures, scale existing ventures, or experiment in new models of sustainability. Through partnerships with the UNCSCA's Kenan Institute and The Center for Creative Economy, we are creating and identifying existing resources for creative entrepreneurs to bring their innovative ideas to fruition with the support they need to be sustainable. We are able to attract and retain these entrepreneurs by having a strong ecosystem for supporting business and offering a community that is vested in culture, education, and a person's well-being.

We are putting more research into the locations and audiences our funded programs are serving in our community and identifying underserved areas and possible collaborations. Our Community Enrichment Mini-Grant programs have enriched and created projects imagined by community groups, neighborhood groups, and schools throughout the county.

We are attending more community meetings, joining committees, serving on boards, and making presentations to share our mission and make sure that the arts have a seat at the table when decisions are being made about community projects. We want the arts to be represented in these decisions and infused into all aspects of the planning, cultivation, and implementation of new projects while enhancing and enriching existing ones.

To truly serve our community through the arts, we have to target certain initiatives that will have a positive impact on our residents. We are fortunate to have people in our community who support the arts, embrace the diversity of the culture experiences we have to offer, and look toward to the innovative cultural experiences yet to be realized. The community will continue to grow and evolve, and the arts and The Arts Council will continue to grow and evolve with it.

## October – November 2016

**Hispanic League** partnered with **Reynolda House Museum of American Art** on Thursday, October 20th to host Columbian classical guitarist, Roberto Martinez in the Colorful Sounds in Concert: Latin America. This partnership celebrated the Hispanic League's 25th Anniversary and brought the two organizations together to explore promoting art and culture to new audiences.

**NC Black Repertory Company** presented a new outreach program entitled, Living Room Theatre, for community members who are not physically able to attend shows at the theatre. They brought actress Perri Gaffney's one-woman show, The Resurrection of Alice, to hospital bound and terminally ill patients at local hospitals, rehab facilities, and nursing homes in October 2016.

**Lewisville Area Arts Council** celebrated its 25th Anniversary of Music in the Park on October 8th at the Shallowford Square in Lewisville. This free community event features the Brothers Pearl band along with musical guests and exhibiting artists. Community partners include Lewisville Recycle Committee, Lewisville Historical Society, Lewisville Civic Club.

**Cross the Line Project** is a project of the **UNCSA Student Board** that featured 5 concerts in October in nontraditional places. UNCSA students performed classical music and engaged their audience about the music as a way to keep classical music relevant. Partners include Homestead Hills Retirement Community, Old Salem Harvest Day Festival, Brookridge Retirement Community, and Reynolda Gardens.

**Piedmont Opera** partnered with the local Girl Scouts Carolinas Peaks to Piedmont Council to create a signature opera badge, provide educational programming and an opportunity to attend Puccini's Tosca at the UNCSA Stevens Center in October.

**WS Shuffle** partnered with CoffeePark Arts located in the Milton Rhodes Center for the Arts to present a monthly showcase competition for artists including music, poetry, dance, and performing arts. The competition was open to artists of all ages and fostered many local talented individuals.

## December 2016 – February 2017

**Shawn Bowman-Hicks, Salem College and The Department of Dance Studies Faculty & Guest Artist Dance Concert** presented the dance work Goldberg Revisited, which brought together student and adult community members in a piece inspired by accessibility and intergenerational movement. The concert was held December 1-3, 2016.

**Historic Bethabara Park** partnered with community artists Peggy Parks and Camille Abbott to develop the Puppet Theater at Historic Bethabara Park. The theater premiered its first original show, A Christmas Eve Curfluffle, at "A Bethabara Christmas" on December 3, 2016.

**Travis Williams** worked with local musicians to create an album entitled, Times of Challenges Volume 2, whose proceeds will directly benefit Cancer Support Services at Wake Forest Baptist Medical Center. Cancer patients created artwork for the album cover as a recreational therapy activity.

## March – May 2017

**ArtWSNC** will collaborate with photographer Kristin Minotti to produce a series of work and exhibition entitled, "Femininity In The Raw", that will feature portraits of local female artists and creators and reflect on what it means to be both a woman and an artist in Winston-Salem.

**Associated Artists of Winston-Salem's** new discussion series, "Art &", will feature community conversations that bridge how the visual arts are connected to everyday themes such as religion, diversity, health and history in order to create a deeper sense of individual and community understanding.

**City of WS Recreation & Parks Department** will work with children in its after-school programs to create murals featuring diversity, sports, arts and technology to display at five recreation centers.

**CNOTE (Create Nothing Other Than Excellence) Foundation** will host "Spring in the City: Fresh Air Kickback" on April 7 at Bailey Park. The event will feature a variety of musicians (hip-hop, soul, and pop music), food trucks, beer and wine, and arts and cultural vendors.

**Diane Faison-McInzie** will present her one-woman performance, "The Spirit of Harriet Tubman", to three historically African American churches in Winston-Salem. Each performance will feature community talks about the performance and the life of Harriet Tubman.

**Family Support Network (at The Centers for Exceptional Children)** will bring in artists to work with their Sibshops program, a family support program for children who have siblings with a disability, in order to use art as a means to increase self-awareness and self-expression.

**Forsyth Education Partnership** will present its 9th annual Poet Laureate competition for Winston-Salem/Forsyth County Schools high school students on April 27.

**Makenna Iselin** a high school junior and American Heritage Girl, will create a resource closet at the Salvation Army Center of Hope that will contain arts-based educational and developmental toys for homeless children and their families to use at the shelter.

**Paideia** a multi-disciplinary collaboration of dance artists and musicians, will perform at the second annual On Site/In Sight, a free three-day dance festival open to the public which takes place May 4 – 6 in downtown Winston-Salem.

**RiverRun International Film Festival's** May RiverRun Retro program entitled Controversial Classics will present the 1956 film, Baby Doll, based upon the play by Tennessee Williams and discussion with the film's actress Carroll Baker and film historian Foster Hirsch.

**SECCA** in collaboration with ABC of NC Child Development Center and The Engaging Educator will work with autistic youth to create an exhibition of art-work that will be on view March 31-April 28 in celebration of Autism Awareness and Acceptance Month.

**The Enrichment Center** will host a gallery opening and reception for their exhibition "Enchanted" on March 24 featuring a variety of artworks made by artists of The Gateway Gallery and a community artist. The exhibition will be on view through May 12.
